To the Citizens of Lamar:

It is a pleasure and with a great sense of accomplishment that the Council, Town Administrator, and I report on the progress of LAMAR for 2024 and half of 2025. Based on planning and our moving forward, we realize this year-and-a-half has been a building time for our town and the surrounding communities. Lamar was incorporated in 1872, and it has gone through many changes in this time. As history often repeats itself, there have been prosperous times and not so prosperous times. We—the Council, Town Administrator, and I—are happy to report that the state of our Town for 2024-2025 has grown and is constantly growing and providing the needs of its citizens. We have always been committed to work to help revitalize Lamar—our goal. Promoting police protection, growing economic development, and improving infrastructure are our ultimate priorities.

Police protection, perhaps better described as public safety and law enforcement, is a priority that is and will always be relevant to the welfare of Lamar. That's putting people first, and at this time the Police Department, under the leadership of a quite capable chief, Chief Dennis Carter, is concentrating on hiring a part-time police officer for safety and protection. Part-time officers hired are enrolled in the South Carolina Police Academy to earn certification. The Police Department is using a grant for \$150,000 from the SC Department of Commerce to furnish needed gear for its officers. This department is looking out for the safety aspect of Lamar's citizens.

To have a thriving Town, economic development is critical, also. We have welcomed more new businesses to Lamar. We continuously highlight old buildings with potential for new economic development. In the 2024-25 year AMERICAN LUXURY COACH moved into the Crowley Manufacturing Building, HOMETOWN PEDIATRICS moved into the Dr. Griffin Building, T & T TOBACCO & VAPE SHOP moved into the building across from the Library, and BRENDA'S PLACE opened in the Tom Langston Building. Also, THE LOGHOUSE STEAK HOUSE opened at Governor's Run, an ICE STATION opened at the carwash, and a LARGE ICE MACHINE is being installed on the lot by the old Subway. As a plus, we must also report that on most days a food truck of some kind is parked somewhere on Main Street. These new businesses are joining the already established ones, "beefing up" the need for jobs. Therefore, employers are hiring employees, citizens are shopping, and visitors are seeking deals. New citizens and prospective citizens are contacting Town Hall to locate housing. New housing is being built on Moonlight Drive and Helen Lane. This is a highly supportive win-win situation--the Town is being revitalized one business at a time.

It is imperative that the Town's infrastructure be brought up-to-date—streets paved, building fronts and awnings refurbished, water and sewer problems addressed, service equipment purchased, and much more. The Town has begun the construction of a new Railroad Avenue Pump Station and Gravity Sewer Project. This project is being funded in part with the South Carolina Infrastructure Investment Program and is funded by Federal, State, and Local Fiscal Recovery Funds. We deal with ordinances, water breaks, water bills, dilapidated buildings, and other problems from day-to-day. Grants must fill the big bills.

All in all, Lamar has progressed pleasingly since the beginning of 2024. In '24 we began to see planning in all areas come to realization. It is especially awesome to report that good financial management now speaks volumes for the Town. What can predict Lamar's future? The future will take all of us working together to continue to make strides for our Town. We must embrace change, continue to prioritize, and look to each other for answers and solutions to everyday and long term problems. Our future is in our hands. Let's continue to go forward! Lamar is a small town, but it has a BIG HEART and a BIG VISION! We must remember, "Small opportunities are often the beginning of great achievements." Thank you for living and working in Lamar.

Zoning Ordinance Book page 8

Home occupations

- 4-3.4 The home occupation shall be conducted only within the principal structure.
- 4-3.5 There shall be no retail sales in connection with such home occupation except for goods produced as part of the home occupation.
- 4-3.6 No equipment or process shall be used in such home occupation which creates noise, vibration, glare, fumes, odors, or electrical interference detectable to the normal senses off the premises. . . .
